MENSTRUAL HYGIENE SCHEME

Will the Minister of **HEALTH & FAMILY WELFARE** be pleased to state:

- (a) Whether the Menstrual Hygiene Scheme, which aims to address the need for menstrual hygiene among adolescent girls residing primarily in rural areas, is fulfilling its unique objectives of improving access to and use of high quality sanitary napkins by adolescent girls;
- (b) if so, the details thereof, State/UT wise along with the relevant details of funds provided to States/ UTs, particularly Kerala, through National Health Missions as per proposals received from them in their Programme Implementation Plans for making provision of sanitary napkin packs to adolescent girls at subsidized rates in the last five years;
- (c) whether any significant steps are being taken to address the anomalies on implementation side and if so the details thereof and if not the reasons thereof; and
- (d) the noteworthy role of Accredited Social Health Activists (ASHAs) under the scheme in Kerala?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) The Scheme for Promotion of Menstrual Hygiene among adolescent girls in the age group of 10-19 years is implemented by the Government since 2011. The major objectives of the scheme are:

- i) To increase awareness among adolescent girls on Menstrual Hygiene
- ii) To increase access to and use of high quality sanitary napkins by adolescent girls.

iii) To ensure safe disposal of sanitary napkins in an environmentally friendly manner.

Since 2015-16, the Menstrual Hygiene Scheme is supported by National Health Mission through State Programme Implementation Plan (PIP) route based on the proposals received from the States.The States have been instructed to take up procurement of sanitary napkins packs at prices reached through competitive bidding.

26 States/UTs are implementing the scheme either with NHM budget or combined budget of NHM and State. In FY 2021-22 approximately 34.92 lakh adolescent girls were provided sanitary napkin packs every month (HMIS data)

The percentage of women age 15-24 using a hygienic method of protection during their menstrual period has also increased from 58 % in National Family Health Survey 4 (NFHS 4) done in 2015-16 to 78 % in NFHS 5 (2019-21). Similarly, the usage of Sanitary Napkins has also increased from 42% to 64%.

(b) State/ UT wise number of beneficiaries under the Menstrual Hygiene Schemes is placed at Annexure 'A'. State/ UT wise funds provided under the Menstrual Hygiene Schemes is placed at Annexure 'B'

(c) No anomalies reported yet however the States/ UTs are also taking up capacity building of the health functionaries supported under NHM to sensitize them towards the scheme and for seamless implementation of the Scheme.

Communication material targeted at adolescent girls, their gatekeepers, influencers and community at large developed by MoHFW, other partner ministries, States, Development Partners and NGOs is in use to create awareness on healthy practices during menstruation and to dispel the myths and misconception around it.

(d) The role of the ASHAs under the Scheme is similar in all States/ UTs. ASHAs hold monthly meetings with the adolescent girls in their area to talk about health issues including menstrual hygiene management .The sanitary napkin packs are provided to the adolescent girls at subsidized rates by the Accredited Social Health Activists (ASHAs).
