Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

(a) whether the Government is implementing any project under Pradhan Mantri Kaushal Vikas Yojana and Skill Acquisition and Knowledge Awareness for Livelihood Promotion in Maharashtra;

(b) if so, the details thereof;

(c) the total number of such projects being implemented in Maharashtra and the number of beneficiaries benefitted under these projects during the last five years;

(d) the total amount of funds spent by the Government on these various projects during the last three years; and

(e) whether the Government propose to review the PMKVY and 'SANKALP' in the near future, if so, the details thereof?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(a) to (c) Yes Sir. Ministry of Skill Development and Entrepreneurship (MSDE) has been implementing Pradhan Mantri Kaushal Vikas Yojana (PMKVY) and Skill Acquisition and Knowledge Awareness for Livelihood Promotion (SANKALP) scheme in the State of Maharashtra. Under PMKVY, training has been imparted to candidates in short term training and recognition of prior learning. Under PMKVY, since inception, i.e., 2015 as on 31.12.2022, 3.55 lakh candidates have been trained in short term training and 8.62 lakh candidates have been oriented in recognition of prior learning in the State of Maharashtra.

Under SANKALP scheme, Rs.22.04 crore was released as State Incentive Grant (as Central share) in 2018-19, to Government of Maharashtra in line with the State's plan. In addition, Rs. 10 lakh was also provided to each aspirational district namely Gadchiroli, Nandurbar, Osmanabad and Washim to strengthen the skilling ecosystem. Further, Ministry has deployed 31 Mahatma Gandhi National Fellows across 31 districts of Maharashtra to support the district skill ecosystem.

(d) Under PMKVY,Rs. 394.86 crorehad been spent during the last three years in the State of Maharashtra.Under SANKALP scheme, Rs. 22.44 crore had been released to Government of Maharashtra.

(e) Based on the learnings from implementation of earlier phases of Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Ministry has conceived the new version of PMKVY, i.e., PMKVY 4.0. PMKVY 4.0 has been appraised and recommended by Expenditure Finance Committee (EFC) and it has also been announced in Budget 2023. The Ministry has started the preparatory work to implement the PMKVY 4.0. Ministry undertakes periodic reviews of the implementation of SANKALP. Further, for SANKALP scheme, joint implementation reviews are organized by the World Bank with the State Skill Development Missions.
