# SHRI JAYADEV GALLA:

Will the Minister of Finance be pleased to state:

- (a) whether the Government has launched the Standup India Scheme in the country, if so, the details thereof;
- (b) the details of Scheduled Caste, Scheduled Tribe and women entrepreneurs beneficiaries under the scheme during each of the last five years, State-wise including Andhra Pradesh and Uttar Pradesh;
- (c) the details of the prospective enterprises for which loans have been disbursed under the scheme, sector-wise;
- (d) whether an evaluative parameter has been established to assess whether or not the green field projects are being carried out successfully post sanction, if so, the details thereof; and
- (e) the number of accounts that have been turned into Non-Performing Assets despite receipt of the loan during the said period, State-wise?

#### **ANSWER**

Minister of State in the Ministry of Finance (Dr. BHAGWAT KARAD)

- (a) & (b) Stand Up India Scheme (SUPI) was launched in April, 2016 to promote entrepreneurship among the Scheduled Caste (SC)/ Scheduled Tribe (ST) and Women by facilitating bank loans of value between Rs. 10 lakh and Rs.1 crore for setting up greenfield enterprises in manufacturing, services, trading sector and activities allied to agriculture. State-wise details, during each of the last five years including Andhra Pradesh and Uttar Pradesh, are as at Annexure-I.
- (c) The details of the prospective enterprises, sector-wise, are furnished below:
