NEW TOURISM PROJECTS IN TELANGANA

Will the Minister of TOURISM be pleased to state:

- (a) whether the Government proposes to come up with any new tourism projects in the State of Telangana;
- (b) if so, the details thereof;
- (c) whether areas have been identified to establish these tourism projects in Telangana; and
- (d) if so, the details of the funds allocated and released so far?

ANSWER

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) to (d): Development and promotion of tourist places is primarily the responsibility of the State Governments/Union Territory Administrations. However, the Ministry of Tourism has provided financial assistance under the 'Swadesh Darshan', 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' Schemes for the development of tourism related infrastructure in the State of Telangana.

The details of projects sanctioned and funds allocated under the above mentioned schemes in the State of Telangana is given at Annexure.

The Ministry of Tourism has now revamped its Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible destinations following a tourist & destination centric approach. Under SD2.0, Bhongir has been identified for development in the State of Telangana.

Proposals are received from State Governments/Union Territory Administrations from time to time for seeking financial assistance under the above schemes of the Ministry of Tourism. These proposals are examined in context of the scheme guidelines and financial assistance is extended for projects subject to fulfilment of the stipulated provisions and availability of funds.
