- d) the details of physical targets set and achieved while implementing the above schemes during the said period and the current year, year/scheme/district-wise;
- e) whether the Government has found any shortcomings while implementing the above schemes and, if so, the manner in which those shortcomings have been fixed; and
- f) whether there is time and cost overrun of any of the above schemes and if so, the reasons therefor?
