Will the Minister of CULTURE be pleased to state

- (a) the details of all elements from India in the UNESCO list of Intangible Cultural Heritage;
- (b) whether the Government has taken any steps towards inclusion of more Indian elements on this list;
- (c) if so, the details thereof and the progress made so far, and if not, the reasons therefor;
- (d) whether the Government is taking any other steps to promote Indian Intangible Cultural Heritage on a global platform;
- (e) if so, the details thereof and if not, the reasons therefor; and
- (f) the other steps taken/being taken by the Government in this regard?

ANSWER

- (a) The details of 14 ICH elements from India which have been included in the UNESCO's Representative List of Intangible Cultural Heritage of Humanity are attached as **Annexure**.
- (b) & (c) As per the latest Operational Directives of UNESCO, only one nomination per submitting country is to be considered every two years. Thus the Government ensures that nominations from India are submitted timely as per UNESCO's mandate.
- (d) to (f) Yes Sir, the Government is administering a Scheme named "Global Engagement Scheme". The Scheme has following two components:
 - 1) Festival of India
 - 2) Grant in aid to Indo Foreign Friendship Cultural Societies Scheme.

The objective of the scheme is to provide artists practicing Indian art forms an opportunity to perform abroad under the banner of Festival of India. The scheme also provides financial assistance to cultural societies actively promoting Indian Culture abroad to organize cultural activities.
