(a) to (c): The district-wise details of projects/schools approved, central funds approved and released to various projects in the last three years and the current year under the scheme of Rashtriya Uchchatar Shiksha Abhiyan (RUSA) in Maharashtra is annexed at Annexure-I. (d): In School Education, the annual plans for the schemes are prepared by the States and UTs based on their requirements, priorities and is presented in their respective Annual Work Plan and Budget (AWP&B) Proposals. These plans are then appraised and approved by the Project Approval Board (PAB) in consultation with the States and UTs as per the programmatic and financial norms of the scheme, and physical and financial progress of the State for the interventions approved earlier. The Government continuously reviews the implementation of the schemes and monitors the progress of the projects through regular review meetings with the States/UTs.
