Will the **Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING**

- (a) the data of the total amount of funds released as premiums for fishermen under the Group Accident Insurance for Active Fishermen Scheme from 2017- 18 to 2022-23, year-wise;
- (b) the data of fishermen who received the premium due to death or permanent total disability, year and State-wise; and
- (c) the data of fishermen in Andhra Pradesh who received the premium due to death or permanent total disability and premium due to partial disablement, year and district-wise?

(a): The year-wise amount of central funds released as premiums for fishermen under the Group Accident Insurance for Active Fishermen Scheme from 2017- 18 to 2019-20 under the erstwhile CSS-Blue Revolution: Integrated Development and Management of Fisheries and from 2020-21 to 2022-23 under Pradhan Mantri Matsya Sampada Yojana(PMMSY) is as under:
