Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state :

- (a) whether the Government has approved Agriculture Infrastructure Fund (AIF) for farmers for setting up small scale industries in the country, State-wise particularly in the State of Haryana and Parliamentary Constituency of Thane in Maharashtra;
- (b) the amount of funds proposed to be allocated to States of Haryana and Maharashtra for the said infrastructure; and
- (c) the names of the projects approved under the said scheme?

ANSWER

(a): Agriculture Infrastructure Fund Scheme(AIF), launched in July 2020 is a Financing facility of Rs. 1,00,000 crore to be lent by Lending Institutions for funding Agriculture Infrastructure Projects relating to decentralised post-harvest management Infrastructure and community farming assets at farm-gate & aggregation points. In order to incentivise the sector and encourage enterprise, interest subvention of 3% per annum and Credit guarantee cover up to a limit of ₹ 2 crore for a maximum period of 7 years is being provided under AIF. This Central sector Scheme covers whole of India. Below given is the progress of AIF in the State of Haryana and Parliamentary constituency of Thane in Maharashtra and other States in general:

So far 804 Projects have been sanctioned with a total approved amount of Rs 683 Crores in the State of Haryana and 19 Projects have been sanctioned with total approved amount of Rs 14.59 Crores in the Parliamentary constituency of Thane in Maharashtra.

- Solarization of grid connected agri-pump under (PM-KUSUM component C)
- Integrated Spirulina production & processing units
- Sericulture processing unit
- Honey processing
- Plant quarantine units
- Projects identified for providing supply chain infrastructure for clusters of crops including export clusters.
- Projects promoted by Central/State/Local Governments or their agencies under PPP for building community farming assets or post-harvest management projects.

Following projects are <u>eligible for only groups</u> such as *FPOs, PACS, SHGs, JLGs, Cooperatives, National and State Level Federation of Co-operatives, FPOs federations, Federations of SHGs, National and State Level Agencies as they qualify as community farming assets: -*

- Hydroponic Farming
- Mushroom farming
- Vertical farming
- Aeroponic farming
- Poly house/ Greenhouse

- Logistics facilities (including non-refrigerated/insulated vehicles)
- Tractors

Note 1: Solarization of any of the eligible infrastructure can also be financed under AIF.

Note 2: Digital Connectivity and optic fiber infrastructure shall be eligible investment as part of development of the aforementioned eligible projects.
