- (a) whether the Government has allocated funds for Uttar Pradesh under various Welfare Schemes of the Ministry;
- (b) if so, the details of the amount allocated, disbursed and spent on each of the welfare schemes in Uttar Pradesh during each the last three years; and
- (c) the total amount allocated to various Non-Governmental Organisations (NGOs) in Uttar Pradesh under various schemes of the Government during the said period?

#### **ANSWER**

## MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SUSHRI PRATIMA BHOUMIK)

- (a) & (b): The focus of the Department of Social Justice and Empowerment is the welfare of the poorest households of the socially, educationally and economically marginalized sections of the society including Scheduled Castes (SCs), Other Backward Classes, Senior Citizens, Victims of Alcoholism and Substance Abuse, Transgender Persons, Beggars, Denotified and Nomadic Tribes (DNTs), Economically Backward Classes (EBCs) and Economically Weaker Section (EWS). This Department is implementing several Schemes for welfare including Uttar Pradesh. The schemes wise fund allocation during last 3 years including Uttar Pradesh is given at Annexure.
- (c): An Amount of Rs. 6,184.15 Lakh released to various Non-Governmental Organisations (NGOs) in Uttar Pradesh under various schemes of the Department during last 3 years i.e. 2019-20 to 2021-22.
