#### 3446. DR. T.R. PAARIVENDHAR:

Will the Minister of YOUTH AFFAIRS AND SPORTS be pleased to state:

(a) whether India gears up to host the biennial event of the 2023 International Boxing Association (IBA), Women's World Boxing Championships for the third time in the tournament's history scheduled to take place from March 15 to 31 in New Delhi;

(b) whether it is true that eight countries including United States of America and United Kingdom have decided to boycott and will not participate in the said championships to be held in New Delhi;

(c) if so, the details thereof and the reasons and circumstances forced these eight countries to boycott the historical event;

(d) the steps taken/being taken by the Government to convince these eight countries through dialogue to participate in the tournament; and

(e) the details and the total number of countries participating in the said championships?

### ANSWER THE MINISTER OF YOUTH AFFAIRS AND SPORTS [SHRI ANURAG SINGH THAKUR]

(a) to (d): Yes, Sir. IBA Women's Boxing Championship 2023 is being hosted by India at New Delhi from 15-31 March 2023.

The Boxing Federation of India (BFI), the National Sports Federation (NSF) for the sport of boxing, is responsible for hosting the international sporting event in the country. The Government supplements the efforts of the NSF by providing financial assistance for holding such international sporting events, if sought by the NSF.

As informed by BFI, 09 countries namely Argentina, Britain, Canada, Ireland, Norway, Poland, Sweden, Switzerland, and United States of America decided not to participate in this championship. It was the decision of these countries. Government of India has no role in the matter.

(e): The list of the 65 countries participating in the said championship is given in Annexure.
