NEW INDUSTRIES IN HARYANA

3455. SHRI DHARAMBIR SINGH:

Will the Minister of **COMMERCE AND INDUSTRY** be pleased to state:

- (a) the details of assistance provided by the Central Government for establishment of new industries in Haryana during the last three years and current-year, company-wise;
- (b) whether there are any proposals pending for the establishment of new industries in Haryana; and
- (c) if so, the details thereof and the time by which such industries are likely to be commissioned?

(a) to (c): Setting up of industries is a State-subject. Government of India, however, provides a lot of support for promotion of industrial activities across the country including the rural areas. Government of India, through the Department for Promotion of Industry & Internal Trade (DPIIT) and other Central Ministries/ Departments, provide an enabling eco-system for the overall industrial development of the country through appropriate policy interventions.

Central Government facilitates industrialization and supplements efforts of State Governments to set up industries through a number of schemes/initiatives implemented by various Ministries/Departments. Under the Indian Footwear and Leather Development Programme, assistance has been provided to the beneficiaries of State of Haryana under Integrated Development of Leather Sector sub-scheme, wherein Rs. 15.61 crore have been approved for 15 units. As part of National Industrial Corridor Programme, Integrated multi-modal Logistics hub at Nangal Choudhary has been approved for State of Haryana. The State of Haryana has been onboarded onto the National Single Window System (NSWS) in

December 2022. NSWWS has mapped 121 approvals across 29 Departments from the State with customized Know Your Approval and State registration form modules. The State has also been integrated under the Vehicle Scrappage scheme for enabling applications to Registered Vehicle Scrapping Facility and Automated Testing Station. Under the Production Linked Incentive Scheme for White Goods, a committed investment of Rs. 515.1 crores with actual investment done as on 31st December 2022 of Rs. 102.33 crores has been made by 10 companies in the State of Haryana. Other major policy interventions for industries includes Make in India, Gati Shakti, Industrial Corridors, Production Linked Incentive Scheme (PLI), Promoting Ease of Doing Business (EoDB) and reducing compliance burden, Start Up India, One District One Product (ODOP), GIS enabled Land Bank, Foreign Direct Investment (FDI) Policy Reforms, Project Monitoring Group to remove bottlenecks in setting up of major infrastructure projects etc.
