Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the number of cards issued under Ayushman Bharat Scheme till date, State/UT-wise including in Karnataka;
- (b) the eligibility criteria set for availing benefits under the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY);
- (c) the funds released to the beneficiaries under the AB-PMJAY during the last five years, State/UTwise;
- (d) whether it is a fact that people are not getting the benefit of said scheme due to indifference of private hospitals and if so, the details thereof alongwith necessary steps taken in this regard; and
- (e) the details of steps being taken by the Government to strengthen healthcare services in various States and to empanel more private hospitals under the scheme?

# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (e): State/UT-wise details of Ayushman Cards issued and funds released during the last five years under Ayushman Bharat- Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) are at Annexure-I. Details of eligibility criteria under the scheme are at Annexure-II. In order to strengthen healthcare services in States/UTs, treatment package rates have been revised, claim settlement has been expedited, capacity building of hospitals is done and a hospital specific toll-free number (14413) to address the concerns of hospitals has been introduced. States/UTs have been provided the flexibility to change hospital empanelment criteria for deficit regions so as to expand the network of private hospitals under the scheme.

# Details of eligibility criteria under AB-PMJAY as per SECC 2011

## Automatically included:

- 1. Households without shelter
- 2. Destitute/ living on alms
- 3. Manual scavenger families
- 4. Primitive tribal groups
- 5. Legally released bonded labour

### Deprivation criteria in rural area:

- D1: Only one room with kucha walls and kucha roof
- D2: No adult member between age 16 to 59
- D3: Female headed households with no adult male member between age 16 to 59
- D4: Disabled member and no able-bodied adult member
- D5: SC/ST households

D7: Landless households deriving major part of their income from manual casual labour

### Occupational criteria in urban area:

- 1. Ragpicker
- 2. Beggar
- 3. Domestic worker
- 4. Street vendor/ Cobbler/ hawker / other service provider working on streets
- 5. Construction worker/ Plumber/ Mason/ Labour/ Painter/ Welder/ Security guard/ Coolie and other head-load worker
- 6. Sweeper/ Sanitation worker/ Mali
- 7. Home-based worker/ Artisan/ Handicrafts worker/ Tailor
- 8. Transport worker/ Driver/ Conductor/ Helper to drivers and conductors/ Cart puller/ Rickshaw puller
- 9. Shop worker/ Assistant/ Peon in small establishment/ Helper/Delivery assistant / Attendant/ Waiter
- 10. Electrician/ Mechanic/ Assembler/ Repair worker
- 11. Washer-man/ Chowkidar
