SHRI SATYADEV PACHAURI:

Will the Minister of ELECTRONICS AND INFORMATION TECHNOLOGY be pleased to state:

- (a) the details of the total number of centres operational for issuing/updating Aadhaar Cards in the country, State/UT-wise particularly in Telangana and Uttar Pradesh;
- (b) the details of new Aadhaar enrolment, updation, figures in Telangana and Uttar Pradesh during the last three years, district-wise;
- (c) whether there is any mechanism or system through which Aadhaar related grievances/inconveniences/allegations can be submitted and if so, the details thereof;
- (d) the details of total funds allocated by the Government to the various States of the country particularly in Uttar Pradesh for Aadhaar Card services, if any, and its utilization thereof;
- (e) the efforts being made to link Aadhaar Card with Voter ID along with the details of the number of Voter ID Cards linked with Aadhaar in Telangana State, district-wise; and
- (f) whether any target has been set for linking Voter ID Card with Aadhaar Card and if so, the details thereof?

ANSWER

MINISTER OF STATE FOR ELECTRONICS AND INFORMATION TECHNOLOGY

(a): Over 65,000 Aadhaar centres were operational across the country as on 28.2.2023, comprising 88 Aadhaar Seva Kendras run by the Unique Identification Authority of India and other centres run by various Registrars appointed by the Authority, such as various Ministries and Departments of the Central Government, State Governments, CSC e-Governance Services India Limited, banks and UTI Infrastructure Technology and Services Limited. In addition, the facility of enrolment of children below the age of five years and update of mobile number is also available through around 32,000 handheld mobiles and tablets, which are operated by postmen, hospital staff, etc. The State-and Union-territory-wise details of such centres and handheld mobile or tablets are at annexure-1.

(b): During the years 2020, 2021 and 2022, the number of new Aadhaar generated in the States of Telangana and Uttar Pradesh were approximately 16.79 lakh and 1.76 crore respectively, and the number of updates done were approximately 1.01 crore and 5.74 crore respectively. District-wise details for the States of Telangana and Uttar Pradesh are at annexure-2 and annexure-3 respectively.

(c): Yes sir. The Authority has provided a facility for residents to give their suggestion and feedbacks, or to complain through various channels, such as by calling a toll-free number (1947), emailing to help@uidai.gov.in, lodging complaints through the Authority's portal or writing to the Authority's offices. (d): The Authority provides financial assistance to State Governments for procurement of Aadhaar enrolment kits. The assistance to States / Union territories were released in 3 phases. An amount of Rs. 26.16 crore was allotted to the State of Uttar Pradesh and Rs. 22.07 crore was utilized. The State- and Union-territory-wise list is at Annexure-4.

(e) and (f): The Ministry of Electronics and Information Technology has conveyed to the Ministry of Law and Justice (Legislative Department) and the Election Commission of India, authorisation of the Central Government for notifying under rule 5 of the Aadhaar Authentication for Good Governance (Social Welfare, Innovation, Knowledge) Rules, 2020, performance of Aadhaar identity authentication, on a voluntary basis, of voters in the National Voters' Service Portal / Voter Portal / Voter Helpline App / ERONET (the centralised software for electoral roll management and form processing). The details of authentication carried out pursuant to such authorisation are not maintained with the Ministry or the Unique Identification Authority of India.
