**CONSUMPTION EXPENDITURE**

**3621. SHRI C. LALROSANGA:**

**Will the Minister of STATISTICS AND PROGRAMME IMPLEMENTATION be pleased to State:**

**(a) whether the Government has decided to release the first revised estimates of national income, consumption expenditure savings and capital formation of the previous fiscal year on the last day of February against the last working day of January, if so, the reasons therefor;**

**(b) the performance of North Eastern States in comparison to the national figure in consumption expenditure, income, savings and capital formation during the last three years, State-wise;**

**(c) whether the Government is trying to evaluate the overall situation in the North East;**

**(d) if so, the details of shortfalls detected therein; and**

**(e) the steps taken to remove these shortfalls?**

**ANSWER**

**MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF STATISTICS AND PROGRAMME IMPLEMENTATION, MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF PLANNING AND MINISTER OF STATE IN THE MINISTRY OF CORPORATE AFFAIRS (RAO INDERJIT SINGH)**

**(a): Yes sir. First Advance Estimate (FAE) of National Accounts for the current year is released by Ministry of Statistics and Programme Implementation (MoSPI) on 7<sup>th</sup> January, if it is a working day, else on previous working day, using the provisional estimate (PE) of previous financial year as benchmark. However, First Revised Estimate (FRE) of the previous financial year used to be released on last working day of**

January, that is one day before the presentation of Union Budget. That was creating confusion among users as they were recomputing growth of current year using FRE released one day before, instead of growth rate published in Economic Survey. Therefore, in consultation with stakeholder agencies, FRE has been made coterminous with the release of Second Advance Estimate (SAE) from the current financial year onward, that is on the last working day of February.

(b): Government does not compile estimates of consumption expenditure, income, savings and capital formation at State level. However, Directorate of Economics & Statistics (DES) of State Government compiles Gross State Domestic Product (GSDP) of respective States. All India Gross Domestic Product (GDP) at current and Constant (2011-12) Prices for last four years are given below:

As per information provided by DES of respective State Government, the GSDP at current and Constant (2011-12) Prices of North Eastern States from 2019-20 to 2022-23 is given in Annexure.

(c) to (e): Fifty five non-exempted Central Ministries/ Departments are mandated to spend at least 10% of their Gross Budgetary Support (GBS) for Central Sector and Centrally Sponsored Schemes in the North Eastern Region (NER) including Assam for the overall development of the region. Under 10% GBS, an expenditure of Rs. 3.84 lakh crore has been incurred by these Central Ministries/ Departments since financial year 2014-15.

Several infrastructure development projects have been taken up by the concerned central Ministries and Departments in North Eastern Region (NER), which, inter-alia, include Road, Air, Rail, Waterways and Telecom Connectivity.
