## SPECIAL CREDIT LINKED CAPITAL SUBSIDY SCHEME

### 3751. MS. MIMI CHAKRABORTY:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

(a) whether it is a fact that the priority sector loans to Micro, Small and Medium Enterprises (MSMEs) by scheduled commercial banks witnessed 11.2 per cent year-on-year growth in December, 2022;

(b) if so, the details of loans disbursed to MSMEs since 2019-20, State-wise;

(c) the details of the Special Credit Linked Capital Subsidy Scheme (SCLSS) for the MSME services sector; and

(d) the number of loan proposals received under MSME sector and sanctioned during 2022-23?

### ANSWER

# MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

(a): As informed by Reserve Bank of India, the growth in outstanding loans to Micro, Small and Medium Enterprises (MSMEs) in December 2022 over December 2021 stood at 14.17%.

(b): The State-wise details on credit disbursed to MSME sector by Scheduled Commercial Banks for the last three financial years, as informed by RBI are attached at Annexure I.

(c) to (d): Under National Scheduled Caste Scheduled Tribe Hub (NSSH) scheme, for technology upgradation of the SC-ST entrepreneurs Special Credit Linked Capital Subsidy Scheme (SCLCSS) is implemented. SC-ST Micro and Small Enterprises (MSEs) of manufacturing as well as service sectors are eligible for 25% capital subsidy for procurement of Plant & Machinery/ Equipment through institutional finance (subsidy cap of Rs. 25 Lakh) without any sector specific restrictions. As on 28.02.2023, under SCLCSS, subsidy amounting to Rs. 155.69 crores has been released to 1,399 applicants.
