#### **LEGACY MUNICIPAL WASTE**

#### **NO. 3765. SHRI ASADUDDIN OWAISI:**

Will the Minister for HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether States and towns have mammoth task of complete remediation of around 48.2 crore tonnes of legacy municipal waste in the next four years;
- (b) if so, whether Government has rolled out the Swachh Bharat Mission (SBM) 2.0 in October, 2021 to get rid of this;
- (c) if so, the extent to which the Mission has been successful in completing its target;
- (d) the details of legacy municipal waste for remediation as on date, State-wise; and
- (e) the steps taken or being taken by the Government in consultation with States and local bodies for remediation of legacy waste to make SBM successful?

#### **ANSWER**

# THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a), (b) & (e): Swachh Bharat Mission (SBM-U) 2.0 has been launched on October 1, 2021 for a period of five years, up to October 1, 2026, with a vision of achieving Garbage Free Status for all cities through 100% source segregation, door to door collection and scientific management of all fractions of waste, including safe disposal in scientific landfills. It is also aimed at remediation of all legacy dumpsites and converting them into green zones. The action plans amounting to ₹3226 crore of Central Share (CS) assistance on remediation of legacy waste dumpsites have been approved so far. An advisory has also been issued to the States/Union Territory Administrations on landfill reclamation which may be accessed at:
