Will the minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether the Government is aware that Kachchh area is comparatively not industrially developed as yet;
- (b) if so, whether the Government has any proposal/ scheme to promote and support new and existing MSMEs for industrial development of Bhuj, Abdasa, Gandhidham, Rapar, Mandvi, Anjar districts of Kachchh Lok Sabha Constituency; and
- (c) if so, the details thereof and if not, the reasons therefor?

(c): The Ministry of Micro, Small and Medium enterprises implements various schemes and programmes for the growth and development of MSME sector in country including the State of Gujarat. These schemes / programmed include Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE), Prime Minister's Employment Generation Programme (PMEGP), Micro and Small Enterprises-Cluster Development Programme (MSE-CDP), Procurement and Marketing Support Scheme (PMS) to MSMEs, Emergency Credit Line Guarantee Scheme (ECLGS), Scheme of Fund for Regeneration of Traditional Industries (SFURTI) and Entrepreneurship and Skill Development Programme (ESDP). The details of Guarantee approved under CGTMSE in the district of Kachchh, cumulative as on February 28, 2023 is ₹ 1,169 crore for 12,243 nos. of beneficiaries.
