- (a) the details of the work done under Smart City projects in Maharashtra;**
- (b) the details of the fund sanctioned/allocated/spent under the projects as on date;**
- (c) whether the Government is satisfied with progress made under the projects;**
- (d) if so, the details thereof;**
- (e) whether all the works under the projects are likely to be completed on fixed time schedule; and**
- (f) if so, the details thereof?**

(a) to (f): Government of India launched Smart Cities Mission (SCM) on 25 June 2015. 100 Smart Cities have been selected through 4 rounds of competition from January 2016 to June 2018.

As on 3 March 2023, 74% of the total projects in Smart Cities of Maharashtra have been completed and 66% of the expected release of funds over the Mission period under SCM has been utilized by its Smart Cities. The progress of implementation of SCM and details of funds released in Smart Cities of Maharashtra are given in Annexure-I.

Projects in Smart Cities are progressing as per respective timelines. The period of implementation of SCM has been extended upto June 2023 and all Smart Cities, including those in Maharashtra, are expected to complete their projects within the stipulated time.
