SCHEMES FOR DRINKING WATER

Will the Minister of JAL SHAKTI be pleased to state:-

- (a) whether new schemes have been formulated by the Government for drinking water and sanitation in Maharashtra and Uttar Pradesh and if so, the details thereof along with the details of the schemes implemented so far;
- (b) the details of the projects, estimated cost and funds released to the States of Maharashtra and Uttar Pradesh, year-wise; and
- (c) the status of progress of each project as on date?

(a) to (c) Since August 2019, Jal Jeevan Mission (JJM), a centrally sponsored scheme, is being implemented in partnership with States, to make provision of potable tap water supply to every rural household of the country including Maharashtra and Uttar Pradesh, on regular and long-term basis.

As reported by Govt. of Maharashtra, at the time of launch of Jal Jeevan Mission in the State on 15th August, 2019, out of 146.73 lakh rural households, 48.44 lakh households (33%) had tap water connections. Since then, 60.10 lakh additional households have been provided with tap water connections. Thus, as on 21.03.2023, the provision of tap water supply is available to 108.62 lakh (74%) households in Maharashtra.

Similarly, as reported by the State Government of Uttar Pradesh, at the time of launch of Jal Jeevan Mission in the State on 15th August, 2019, out of 265.18 lakh rural households, 5.16 lakh (2%) households had tap water connections. Since then, 84.93 lakh additional households have been provided with tap water connections. Thus, as on 20.03.2023, the provision of tap water supply is available to 90.10 lakh (34%) households in Uttar Pradesh.

Power to plan, approve and implement water supply schemes under Jal Jeevan Mission is vested with respective State Governments. Under JJM, project wise fund allocation is not made and maintained at Government of India level. However, year-wise details of Central fund allocated, fund drawn and fund utilization reported by the State of Maharashtra and Uttar Pradesh under Jal Jeevan Mission, are at **Annex.I**

In respect of Sanitation, Swachh Bharat Mission (Grameen) [SBM(G)], a Centrally Sponsored Scheme, was launched w.e.f. 2nd October, 2014 with the aim to achieve Open Defecation Free (ODF) status in rural areas of all the States/ UTs of the country (including those of Maharashtra and Uttar Pradesh) by providing access to toilets to all the rural households. As reported by the States/UTs on the online Integrated Management Information System (IMIS) of SBM(G), till 2019-20, more than 10 crore Individual Household Latrines (IHHLs) were constructed across the country under the programme including 65.03 lakh in Maharashtra and 205.63 lakh in Uttar Pradesh and all the villages of the country had declared themselves ODF by 2nd October, 2019.

Having achieved the ODF status, Phase II of SBM(G) has been launched with effect from 1st April, 2020 for a period of 5 years with the objective to sustain the ODF status and to make arrangements for Solid and Liquid Waste Management (SLWM) in all the villages of the country (including that of Maharashtra and Uttar Pradesh).

As reported by the States/ UTs on IMIS of SBM(G), number of villages covered with Solid Waste Management (SWM), Grey Water Management (GWM), no. of IHHLs constructed and no. of Community Sanitary Complexes (CSCs) constructed under SBM(G) Phase-II, in Maharashtra and Uttar Pradesh are as under:
