NO. 3837. SHRIMATI VEENA DEVI:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of the works done under Jal Jeevan Mission-Urban (JJM-U) during the last three years and the current year in the country, State/UT wise including Bihar and Uttar Pradesh;
- (b) the percentage of urban houses wherein tap connection for water have been provided in Vaishali/ Muzaffarpur district of Bihar during the said period;
- (c) the funds sanctioned, allocated and utilized for the said works during the last three years along with the details thereof; and
- (d) the number of houses in Vaishali/Muzaffarpur district of Bihar where provision of water from taps has been/has yet not been made through the said mission along with the details thereof?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a): The proposed Jal Jeevan Mission – Urban scheme has been launched as Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0 for a period of 05 years i.e. from the financial year 2021-22 to 2025-26. The mission aims at making the cities 'water secure' and provide universal coverage of water supply through functional taps to all households in all the statutory towns in the country. Mission also aims at providing sewage/ septage management to all households of 500 cities covered in first phase of the AMRUT scheme. State-wise status of projects approved since launch of AMRUT 2.0 in October 2021 is at ANNEXURE.

- (b): Overall, in Vaishali district 45% of urban households have been covered with tap connection; & in Muzaffarpur district, 68% of urban households have already been covered with tap connection.
- (c): The funds under AMRUT 2.0 are released to States/Union Territories (UTs), State Water Action Plan-wise respectively & not project-wise. Under AMRUT 2.0, against the committed central assistance of ₹66,750 for projects, ₹5,317.97 crore has been released so far for projects & ₹528.47 crore has been released for Administrative &Office Expenses (A&OE). Against which, utilisation certificates worth ₹89.97 crore have been received for projects & ₹40.80 crore for A&OE.
- (d): 51,617 urban households in Muzaffarpur district (out of 1.59 lakh households) & 63,674 urban households in Vaishali district (out of 1.15 lakh households) are yet to be provided with tap connections(as in 2021, as provided/ updated by State on AMRUT 2.0 portal).
