Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether the Government has failed to boost the MSME sector in the country and if so, the details thereof and the reasons therefor;
- (b) the number of MSMEs currently in operation in Odisha and Tamil Nadu, district-wise;
- (c) the number of employment opportunities created by the MSMEs in country particularly in Odisha and Tamil Nadu;
- (d) whether the Government has conducted any survey of the closed MSMEs and if so, details thereof;
- (e) whether the Government proposes to provide employment, subsidies and financial compensation to persons affected by the closure of MSMEs, if so, details thereof and if not, reasons therefor;
- (f) the number of applications filed on the MSME Samadhaan platform, viewed by Officials and pending consideration, annually from inception till date; and
- (g) whether many of applications on MSME Samadhaan portal are currently pending and if so, the reasons for such a large number of pendencies?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

- (a) & (e): The Central Government supplements the efforts of the State/UT Governments through various schemes, programmes and policy initiatives for overall development and promotion of Micro, Small and Medium Enterprises (MSMEs) in the country. A number of recent steps have been taken by Government, including AatmaNirbhar Bharat Abhiyaan to promote the MSME sector in the country. These include:
 - 1. Launch of Rs. 5 lakh crore Emergency Credit Line Guarantee Scheme (ECLGS) for businesses, including MSMEs in 2020. As reported by Department of Financial Services (DFS), under ECLGS as on 28.2.2023, total 1.19 crore guarantees amounting to Rs. 3.62 lakh crore have been provided to businesses, including MSMEs.
 - 2. Rs. 50,000 crore equity infusion through Self Reliant India Fund (SRI): As on 28.2.2023, total 36 Daughter Funds have been empanelled with NSIC Venture Capital Fund Limited and by way of investing more than Rs. 2,790 crore, 142 potential MSMEs have been assisted.
 - 3. New revised criteria for classification of MSMEs.
 - 4. No global tenders for procurement up to Rs. 200 crores.

- 5. "Udyam Registration" for MSMEs, for Ease of Doing Business w.e.f. 1.7.2020. On Udyam, 1.50 crore Micro, Small and Medium Enterprises (MSMEs) have been registered & classified and are providing employment to more than 10.69 crore people.
- 6. Launching of an online Portal "Champions" in June, 2020 to cover many aspects of egovernance including grievance redress and handholding of MSMEs.
- 7. Inclusion of Retail and Wholesale traders as MSMEs w.e.f. 2.7.2021.
- 8. Non-tax benefits extended for 3 years in case of an upward change in status of MSMEs w.e.f. 18.10.2022.
- 9. Launch of Udyam Assist platform on 11.1.2023 to bring Informal Micro Enterprises (IMEs) under the formal ambit for availing benefits under Priority Sector Lending. Since then as many as 13.33 lakh IMEs have registered.
- (b): The district-wise number of MSMEs currently in operation in Odisha and Tamil Nadu, from 1.7.2020 till 20.3.2023, as per information available on Udyam, are at Annexure-I & II.
- (c): As per Udyam Portal, from 1.7.2020 till 20.3.2023:
 - I. total 3.20 lakh MSMEs have been registered & classified and are providing employment to more than 27.69 lakh people in Odisha and;
 - II. total 15.57 lakh MSMEs have been registered & classified and are providing employment to more than 1.19 crore people in Tamil Nadu.
- (d): As per the study conducted by SIDBI during September, 2021 to January, 2022 for a sample size of 1,029 MSMEs spread across 20 States and 2 UTs, around 65% of the MSMEs surveyed, have availed the benefits under ECLGS under AatmaNirbhar Bharat Abhiyan and around 36% of the respondents (MSMEs) also availed loans under the Credit Guarantee Fund Trust for Micro & Small Enterprises (CGTMSE) Scheme. The study revealed that 67% of the respondent MSMEs were temporarily closed up to a period of three months due to COVID-19 pandemic. State Bank of India's research report dated 06.01.2022 on ECLGS, indicates that almost 13.5 lakh MSME accounts were saved due to ECLGS scheme (including restructured), of which about 93.7% of the accounts were in Micro and Small category.
- (f) & (g): The Year-Wise number of applications filed on the MSME Samadhaan from inception i.e. 30.10.2017 till 20.03.2023 and the number of applications pending and mutually settled as on 21.03.2023 are at Annexure-III.
