Funds under JJM

3883. SHRI P.P. CHAUDHARY: SHRI ANURAG SHARMA:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the details of the funds sanctioned and released by the Government under Jal Jeevan Mission (JJM) in the State of Rajasthan and Uttar Pradesh during the last three years, year-wise;
- (b) whether the percentage of pipe/tap water connections has increased in Rajasthan and if so, the details thereof, district-wise;
- (c) whether all the houses in Pali, Rajasthan and Jhansi, Uttar Pradesh have received a tap water connection till date and if so, the details thereof; and
- (d) whether there is a timeline for providing pipe water connectivity to all the rural households in the country and if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR JAL SHAKTI (SHRI PRAHLAD SINGH PATEL)

(a) to (d) Since August 2019, Government of India, in partnership with State Governments, is implementing Jal Jeevan Mission (JJM)-Har Ghar Jal to enable every rural household in the country, including those in the States of Rajasthan and Uttar Pradesh, to have assured potable water through tap water connection by 2024.

At the time of announcement of Jal Jeevan Mission in August 2019, 11.74 lakh (10.89%) rural households were reported to have tap water connections in the State of Rajasthan. So far, as reported by the State as on 20.03.2023, additional 25.24 lakh rural households have been provided with tap water connections in last three and half years under JJM. Thus, as on 20.03.2023, out of 1.08 Crore rural households in the State, around 36.98 lakh (34%) households are reported to have tap water supply in their homes.
