# †394. SHRI MAHABALI SINGH:

#### Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

(a) whether the Ministry proposes to open new Jan Aushadhi Kendra in Karakat, Bihar;

(b) if so, the details thereof;

(c) the target fixed by the Government regarding opening of new kendra across the country during the current financial year;

(d) the details of the progress made in this regard so far; and

(e) the details of the sale of Suvidha Sanitary Napkins in Jan Aushadhi Kendra across the country during the years 2019-20 and 2020-21, State-wise and year-wise?

# ANSWER

# MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI BHAGWANTH KHUBA)

(a) & (b): Under the Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP) implemented by the Pharmaceutical and Medical Devices Bureau of India (PMBI), a society under the aegis of the Department of Pharmaceuticals, about 9,000 Pradhan Mantri Bhartiya Janaushadhi Kendras (PMBJKs) have been set up across the country. Out of which, about 350 PMBJKs have been opened in the state of Bihar including 13 kendras in Rohtas district. PMBI has recently invited online applications from various blocks/ districts in the country including Karakat block under Rohtas district of Bihar. No application, however, has been received from the block.

(c) & (d): Government has set a target to open about 9,300 PMBJKs across the country during the current financial year i.e. 2022-23. As on 30.01.2023, about 9,082 PMBJKs have been opened in the country.

(e): Jan Aushadhi Suvidha Sanitary Napkins are available for sale at PMBJKs across the country @ Rs. 1.00 per sanitary pad. Financial year-wise and State/UT-wise sales of Jan Aushadhi Suvidha Sanitary Napkins for the financial years 2019-20 & 2020-21 is enclosed as **Annexure.**
