### 3956 SHRI ANURAG SHARMA: SHRI P.P. CHAUDHARY:

Will the Minister of **HEALTH and FAMILY WELFARE** be pleased to state:

- (a) the number of standardized personal health records established under the National Digital Health Mission, State/UT-wise, including Rajasthan and Uttar Pradesh;
- (b) the details of the benefits arising from such standardization of health records;
- (c) whether the Government proposes for standardizing personal health records for the entire population; and
- (d) if so, the details thereof?

(a) to (d) Ayushman Bharat Digital Mission aims to create National Digital Health Ecosystem across the country and create longitudinal Electronic Health Record of all citizens for seamless data exchange among the different health entities.

Under the Ayushman Bharat Digital Mission (ABDM), earlier the National Digital Health Mission, health records are linked to an ABHA (Ayushman Bharat Health Account) number. These linked health records serve as the users' personal health records, and are available to the user in their Personal Health Records (PHR) app. This application facilitates an individual/users to share their records with any other healthcare provider with prior consent. The state-wise detail of ABHA linked records is at Annexure.

The standardized/structured data is key to enable interoperability within the healthcare ecosystem. This allows a citizen to maintain their longitudinal health history, store their health data at one place, such as in a health locker, share their health records with different healthcare service providers as warranted across facilities, geographies, physicians etc.

It also helps healthcare service providers to view patients' health history and help in providing better care. Standardization in data can also help in data aggregation which can in turn support evidence-based policy making and research in the healthcare ecosystem.
