Will the Minister of HEALTH & FAMILY WELFARE be pleased to state:

- (a) the funds allocated and utilized for Rashtriya Kishor Swasthya Karyakram (RKSK) during the last three financial years and provisional data for the current year, State/UTwise;
- (b) the number of adolescents benefited through RKSK in the country during the last three financial years and the current year, State/UT-wise along with district-wise data for Tamil Nadu;
- (c) the number of sanitary napkins distributed under RKSK in the country during the last three financial years and the current year, State/UT-wise along with district-wise data for Tamil Nadu;
- (d) whether the Government has noted concerns from experts that challenges of teenage pregnancy, early marriage, anaemia and high maternal mortality continue to persist due to poor implementation of RKSK; and
- (e) if so, the reaction of the Government thereto?

- d) & e) Rashtriya Kishor Swasthya Karyakram covers all adolescents in the age group of 10 to 19 years. With the sustained implementation of this programme, the positive outcomes are now reflected in the National level surveys. The recent National Family Health Survey 5 (NFHS 5) data shows that the overall prevalence of early marriages has reduced from 26.8% in NFHS 4 to 23.3% in NFHS5. Teenage pregnancies have also gone down from 7.9% to 6.8% between NFHS 4 and 5. Teenage pregnancies are a critical factor for maternal deaths among the adolescents. Maternal deaths in the age group 15-19 years is low at 6% (SRS, 2018-20).

In order to intensify the efforts of the Government in reducing the prevalence of Anemia, the Ministry of Health and Family Welfare (MoHFW) has launched Anemia Mukt Bharat (AMB) strategy in 2018 with the objective to reduce anaemia in children, adolescents, women including pregnant women and lactating women in life cycle approach, providing preventive and curative mechanisms through a 6X6X6 strategy. Under the Weekly iron and Folic Acid Supplementation programme Prophylactic Iron Folic Acid Supplementation is done for in schools (6th- 12th Class) and Out of School adolescent girls however anemia is a multi-faceted problem and addressing non-nutritional causes of anemia in endemic pockets, with special focus on malaria, haemoglobinopathies and fluorosis is equally important.
