#### **VACANCIES IN MINISTRY**

### 4072. SHRI DEEPAK BAIJ:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the number of vacancies in the Ministry of Women and Child Development (main Secretariat) along with the subordinate bodies, organisations/institutions under administrative control of Ministry, separately as on date, group-wise and category-wise;
- (b) the details of funds allocated, released and utilized for filling up of vacancies in above secretariat, organizations, bodies, institutions etc. separately during 2022-23 till date; and
- (c) the details of vacancies filled during 2022-23 till date in main Secretariat, subordinate organizations, bodies, institutions etc. separately?

#### **ANSWER**

## MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) All schemes of the Ministry of Women and Child Development have been revamped and converged into 3 Missions, namely, (i) Mission Saksham Anganwadi and POSHAN 2.0, (ii) Mission Shakti and (iii) Mission Vatsalya, for optimum utilization/rationalization of manpower. Moreover, in respect of Ministry's associate offices, the Government has decided to close down CSWB, FNB and RMK as per recommendations in the report on 'Rationalization of Government Bodies' prepared by the Principal Economic Advisor to the Government of India in November, 2020.

The details of group-wise/category-wise vacancies as on date in respect of the Ministry (main Secretariat) and its associate offices are given at Annexure-I.

(b) No separate fund is allocated for filling up of vacancies in the main Secretariat or associate offices of the Ministry. The expenses are incurred through budget allocated under Salary Head of the Ministry and respective associate offices. The budget allocated and released under the Salary Head are as under:

(c) The posts of the Ministry (Main Secretariat) under Central Staffing Scheme (CSt.S), Central Secretariat Service (CSS), Central Secretariat Service (CSSS), Central Secretariat Clerical Service (CSCS), Indian Economic Service (IES), Indian Statistical Service (ISS) and Central Secretariat Official Language Service (CSOL) are filled by respective Cadre Controlling Authorities viz. DoPT, D/o Economic Affairs, M/o Statistics & Programme Implementation and D/o Official Language on recruitment/promotion/deputation/transfer in respective grades. The Ministry has no role in filling up these posts, except intimating vacancies and requesting the concerned Cadre Controlling Authorities to fill up their respective posts, which has been done on regular basis. For filling up vacancies of Group C posts for which the Ministry is Cadre Controlling Authority and the vacancies in associate offices which are mainly deputation posts, Staff Selection Commission has been notified/advertisements have been circulated.
