4083. SHRI UPENDRA SINGH RAWAT:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be please to state:

- a. whether the Government has any proposal to increase the number of Child Care Centres in the country;
- b. if so, the details thereof State/UT-wise and district-wise in Uttar Pradesh;
- c. the number of such centres managed by the Government and the private sectors separately across the country, State/UT-wise along with the number of children benefitted from them and the facilities provided to the children therein;
- d. whether the Government has proposed any expansion in the coverage of Nutrition Programme for Adolescent Girls; and
- e. if so, the details of districts/States identified so far in this regard and if not, the reasons therefor?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

- (a) & (b): Increase in Child Care Institutions depends on the proposal of the State/UT based on the particular need of the region.
- (c): The Ministry is implementing a centrally sponsored scheme namely Mission Vatsalya through State and UT Governments for delivering services for Children in Need of Care and Protection (CNCP) and Children in Conflict with Law (CCL). The Child Care Institutions (CCIs) established under the scheme support *inter-alia* age-appropriate education, access to vocational training, recreation, health care, etc. State-wise number of CCIs including Non-Government Organisation run which are funded by the Government and beneficiaries supported under Mission Vatsalya Scheme (as on 31.03.2022) are at Annexure-I. There are also CCIs which are NGO run but government supported. Their details are given at Annexure-II. Data regarding CCIs managed by private sectors is not maintained centrally.
- (d) & (e): The Ministry of Women and Child Development is implementing a Centrally Sponsored Scheme namely Scheme for Adolescent Girls, under Mission Saksham Anganwadi & Poshan 2.0 covering Adolescent Girls in the age group of 14 to 18

years in Aspirational Districts of States. The Scheme aims at providing nutritional support to Adolescent Girls (AGs) (14-18 years) for improving their health and nutritional status under the nutrition component and providing them Iron Folic Acid (IFA) supplementation, Health check-up and Referral Service, Nutrition & Health Education and Skilling etc. under non-nutrition component of the Scheme. Presently there is no such proposal for expansion in the coverage of the Scheme.
