Will the Minister of FINANCE be pleased to state:

(a) whether the Government has any details of the tax payers in old regime and new regime also who are filing income tax returns and deducting their tax in the country since 2012 onwards to till date and if so, the details thereof, Government/private, employee-wise; and;

(b) whether the Government is giving any incentive or any type of benefit to tax payers in the country and if so, the details thereof and if not, the reasons therefor ?

(a). The details of number of Govt. Employees filing income tax returns and total taxpayers for Financial Year (FY) 2012-13 to FY 2020-21 is as per **Annexure I**, new tax regime for individual taxpayers was made applicable from Assessment Year (AY) 2021-22 and that for corporate taxpayers from AY 2017-18.

(b). For the ease and benefit of taxpayers, most of the taxpayer services, from PAN registration to filing of income tax returns (ITRs) and issuance of refunds, have been made online.
