Will the MINISTER OF CULTURE be pleased to state:

- (a) whether the Government provides pensions to the artists of traditional folk theatre, folk arts and folk dance;
- (b) if so, the State/UT-wise details of the pension provided to various artists so far as on date;
- (c) whether the Government proposes to provide pension to the artists who perform Gawari dance of Rajasthan; and
- (d) if so, the details thereof and if not, the reasons therefor?

(a) The Government administers a Scheme namely "Scheme for Financial Assistance for Veteran Artists" under which financial assistance is provided to the veteran artists including the artists of traditional folk theatre, folk arts and folk dance artists of the age of 60 years and above having annual income not more than 48,000/-.

- (b) The State/UT-wise details of financial assistance provided to various artists during last four years and the current year are given at **Annexure**.
- (c)&(d) As stated above, financial assistance is provided to veteran artists of all genres of the age of 60 years and above living in penury condition including the artists performing Gawari dance of Rajasthan. The numbers of artists supported and amount of financial assistance provided during the last three years and the current year are as under:-
