SAMGARA SHIKSHA SCHEME 2.0 FOR UNIVERSALISATION OF QUALITY EDUCATION

Will the Minister of EDUCATION be pleased to state:

- (a) whether the Government has approved Samagra Shiksha Scheme 2.0 under School Education Programme for universalization of quality education;
- (b) if so, the objective, salient features and main focus of the scheme thereof;
- (c) the steps being taken to improve access of girls to education and to ensure that girls complete their school education from pre-school up to 12th class in all States of the country under the said scheme;
- (d) whether any time limit has been fixed to provide facility of ICT labs, smart classrooms including support for digital boards, virtual class and DTH Channels in all schools across the country; and
- (e) if so, the details thereof?

ANSWER

(a) to (c): The Department of School Education and Literacy is implementing an Integrated Centrally Sponsored Scheme for School Education- Samagra Shiksha since 2018-19. The scheme has now been redesigned and aligned with the recommendations of the National Education Policy, 2020 and continued till 2025-26. It aims to ensure that all children have access to quality education with an equitable and inclusive classroom environment which should take care of their diverse background, multilingual needs, different academic abilities and make them active participants in the learning process.

The major objectives of the Scheme are: (i) Support States and UTs in implementing the recommendations of the National Education Policy 2020 (NEP 2020); (ii) Support States in implementation of Right of Children to Free and Compulsory Education (RTE) Act, 2009; (iii) Focus on Early Childhood Care and Education; (iv) Emphasis on Foundational Literacy and Numeracy; (v) Thrust on Holistic, Integrated, Inclusive and activity based Curriculum and Pedagogy to impart 21st century skills among the students; (vi) Provision of quality education and enhancing learning outcomes of students; (vii) Bridging Social and Gender Gaps in School Education; (viii) Ensuring equity and inclusion at all levels of school education; (ix) Strengthening and up-gradation of State Councils for Educational Research and Training (SCERTs)/State Institutes of Education and District Institutes for Education and Training (DIET) as nodal agency for teacher training; (x) Ensuring safe, secure and conducive learning environment and maintenance of standards in schooling provisions and (xi) Promoting vocational education.

The major features and interventions of Samagra Shiksha for improving the access, infrastructure and quality of education throughout the country are (i) Universalizing access to quality school education by expansion of schooling facilities in the uncovered areas through up-gradation of schools up-to senior secondary level (ii) Ensuring availability of adequate infrastructure to ensure that schools conform to the prescribed norms (iii) Annual Grant of Rs. 5,000 to Rs. 20,000/- per school for strengthening of Libraries (iv) Composite school grant of Rs. 25,000-1 Lakh to be allocated on the basis of school enrolment, out of which at-least 10% is to be spent on Swachhta Action Plan (v) Annual Grant for sports equipments at the cost of Rs. 5000-25000 per school (vi) Allocation for children with Special Needs (CwSN) of Rs. 3,500 per child per annum including a stipend of Rs. 200 per month for CWSN girls to be provided from Classes I to XII (vii) Allocation for uniforms at the rate of Rs. 600 per child per annum at elementary level (viii) Allocation for textbooks at the rate of Rs. 250/400 per child per annum at elementary level (ix) Running and Upgradation of Kasturba Gandhi Balika Vidyalayas (KGBVs) from Class 6-8 to Class 6-12 (x) Strengthening Teacher Education Institutions like SCERTs and DIETs to improve the quality of teachers (xi) Enhanced use of digital technology in education through smart classrooms, digital boards and DTH channels (xii) Support States & UTs for implementation of provisions of RTE Act, including reimbursement under Section 12(1)(c) of the Act (xiii) Setting up of residential schools and hostels for difficult areas and for children in difficult circumstances.

Under Samagra Shiksha, various interventions have been targeted for girls, which include opening of schools in the neighbourhood to make access easier for girls, free uniform and text-books to girls up to Class VIII, additional teachers and residential quarters for teachers in remote/hilly areas, appointment of additional teachers including women teachers, stipend to CWSN girls from class I to class XII, separate toilets for girls, teachers' sensitization programmes to promote girls participation, gender-sensitive teaching-learning materials including text books etc.

Further, under Samagra Shiksha, special state specific projects for varied interventions under equity are emphasized for enhancing access, retention and quality for girls by promoting enrolment drives, retention and motivation camps, gender sensitization modules etc. Such projects include life skills, awareness programmes, incinerators, sanitary pad vending machines etc.

To reduce gender gaps at all levels of school education, there is a provision of Kasturba Gandhi Balika Vidyalayas (KGBVs) under Samagra Shiksha. KGBVs are residential schools from class VI to XII for girls belonging to disadvantaged groups such as SC, ST, OBC, Minority and Below Poverty Line (BPL). The KGBVs are set up in Educationally Backward Blocks (EBBs) of a State/UT where the female rural literacy rate is below the national average. Under Samagra Shiksha, provision has been made to upgrade/converge the KGBVs/Girls' Hostel, as feasible, up to senior secondary level.

(d) & (e): Under the Samagra Shiksha scheme, financial assistance is provided to States and UTs for undertaking various activities for universalisation of school education including setting up of ICT Labs and Smart Class rooms.

The financial assistance is based on the annual plans prepared by the States and UTs as per their requirements/ priority and is reflected in their respective Annual Work Plan and Budget (AWP&B) Proposals. These plans are then appraised and approved/estimated by the Project Approval Board (PAB) in the Department of School Education & Literacy in consultation with the States and UTs as per the programmatic and financial norms of the scheme and physical and financial progress of the State for the interventions approved earlier.

The ICT and Digital Initiatives component of Samagra Shiksha covers Government and Government aided Schools having classes VI to XII as per the following provisions:

A. Budgetary provisions

The non- recurring/recurring grant under 'ICT and Digital Initiatives' for schools is available to the States and UTs for following two options:

Option I: Under this option, schools which have not availed the ICT facility earlier can either opt for ICT or smart classrooms as per their requirement and need. In case of more than 700 enrolments, an additional ICT lab can also be considered.

Option II: Under this option, schools which have already availed the ICT facility earlier can avail smart classrooms/tablets as per the norms of the scheme.

B. Financial provisions

ICT Lab: A non-recurring grant of up to ₹ 6.40 lakh per school and recurring grant of upto ₹ 2.40 lakh per school per annum for a period of 5 years.

Smart Classrooms: The non-recurring grant for Smart Class rooms is of ₹ 2.40 lakh and the recurring grant is ₹ 0.38 lakh. To facilitate online education, a comprehensive initiative called PM eVIDYA has been initiated as part of Atma Nirbhar Bharat Abhiyaan on 17th May, 2020, which unifies all efforts related to digital/online/on-air education to enable multi-mode access to education. The initiative includes:

- DIKSHA (one nation, one digital platform) is the nation's digital infrastructure for providing quality e-content for school education in states/UTs and QR coded Energized Textbooks for all grades are available on it.
- One earmarked Swayam Prabha TV channel per class from 1 to 12 (one class, one channel).
- Extensive use of Radio, Community radio and CBSE Podcast- Shiksha Vani.
- Special e-content for visually and hearing impaired developed on Digitally Accessible Information System (DAISY) and in sign language on NIOS website/ YouTube.
