CSR SPENDING IN TELANGANA**

QUESTION

4312. SHRI ANUMULA REVANTH REDDY:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) whether it is a fact that no Corporate Social Responsibility (CSR) funds were spent in the five backward districts of Telangana which includes Jagtial, Peddapalli, Jayashankar Bhupalpally, Nagarkurnool and Jogulamba and if so, the details thereof and the reasons therefor;**
- (b) the details of the amount spent on CSR projects in Telangana during each of the last five years, year/district-wise including Malkajgiri district; and**
- (c) the details of the key areas where companies spent their CSR funds in Telangana since the year 2018, area/year-wise?**

(a) to (c): The broad framework for Corporate Social Responsibility (CSR) has been provided under Section 135 of the Companies Act, 2013 ('Act'), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. Under the Act, CSR is a Board driven process and the Board of the company is empowered to plan, decide, execute and monitor CSR activities of the company based on the recommendation of its CSR Committee. The Government does not issue any specific direction to the companies to spend in any particular geographical area or activity.

The CSR framework is disclosure based and CSR mandated companies are required to file details of CSR activities annually in the MCA21 registry. All data related to CSR filed by companies in MCA21 registry is available in public domain at www.csr.gov.in. On the basis of annual filings made by companies in the MCA21 registry, District-wise details (including Jagtial, Peddapalli, Jayashankar Bhupalpally, Nagarkurnool, Jogulamba and Medchal Malkajgiri district) of the CSR spent by companies in the State of Telangana during the Financial Years (FY) 2016-17, 2017-18, 2018-19, 2019-20 and 2020-21 are at Annexure - I.

Development Sector-wise details of CSR spent by companies in the State of Telangana during the FY 2017-18, 2018-19, 2019-20 & 2020-21 are at Annexure - II. Further, the companies are required to file the CSR data for the financial year 2021-22 on or before 31.03.2023.
