REGISTRATION OF E-SHRAM PORTAL IN BIHAR

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) the number of labourers in the unorganised sector registered in e-Shram Portal till 2022 in Bihar;**
- (b) the type of social security provided by the Government to workers registered on the said Portal;**
- (c) the number of workers in West Champaran district who are registered on the said Portal provided employment in the year 2022;**
- (d) the aims and objectives of the e-Shram card being provided to the labourers in the country by the Union Government, if so the details of the benefits being provided to the labourers in the country through the said card; and**
- (e) the number of labourers who have been provided e-Shram cards since its introduction, State/UT-wise?**

ANSWER

(a) to (e): As on 31st December 2022, 2.85 Crore unorganised workers have registered on eShram portal in the State of Bihar. In West Champaran district a total of 11,39,284 unorganised workers have registered out of which, 4050 have joined National Career Service (NCS) portal for employment opportunities.

As on 11th March 2023, a total of 28.64 crore labours/unorganised workers have registered on eShram portal. The State/ UT-wise data of eShram registrants are annexed.

The aim and objective of eShram card is to provide Universal Account Number (UAN) which can work as a unique identifier across various social security schemes including skilling and employment opportunities.

In order to facilitate benefit of social security schemes to the eShram registrants, eShram portal is integrated with Pradhan Mantri Shram-Yogi Maandhan (PM-SYM) portal. The eShram registrants can seamlessly take benefits of PMSYM pension scheme through this integration. The eShram portal is also integrated with National Career Service (NCS) Portal. The eShram registrants can seamlessly register on NCS portal and search for suitable job opportunities.

The data sharing of eShram with the State/ UT Governments has been initiated which will facilitate targeted delivery and monitoring of the social security/welfare schemes implemented by the respective State/UT Governments. Further, data sharing guidelines with Central Ministries/ Departments has also been issued on 02.03.23 for exchange of eShram data with Central Ministries/ Departments.
