#### **ASHA PROJECT**

#### 4341. SHRI DIPSINH SHANKARSINH RATHOD:

Will the Minister of EDUCATION be pleased to state:

- (a) the details of the Accredited Social Health Activist (ASHA) Project given to National Institute of Open Schooling (NIOS);
- (b) if so, the details of the purpose for which the ASHA project was given to NIOS and the year by which the given project will be made functional by (NIOS);
- (c) the details about the funds received by NIOS during the last six years, State-wise along with the expenditure by each State;
- (d) the details of the vacant period of ASHA staff in Gujarat NIOS;
- (e) whether the Government has any details about the funds used for ASHA Project during 2017 to 2022;
- (f) if so, the details of funds used and unused;
- (g) the details of the salary paid to State Consultant and Project Assistant of ASHA Project; and
- (h) the details of the work progress from 2017 to 2022, year-wise?

#### **ANSWER**

### MINISTER OF STATE IN THE MINISTRY OF EDUCATION (DR. SUBHAS SARKAR)

(a) and (b): A Memorandum of Understanding (MoU) was signed between Ministry of Health and Family Welfare (MoHFW), National Health System Resource Centre (NHSRC) & National Institute of Open Schooling (NIOS) for Skill Development, Assessment & Certification of 9 lakh ASHA health workers in the year 2014. The duration of the project was initially for the period from 2014 – 2019 and was further renewed upto 2024.

- (c): Funds are received for the project as a whole and not State-wise. Total funds received by NIOS for the period 2014-19 is Rs.7,64,72,049/-. Expenditure is made against total number of registration and certification of ASHA in the State. Expenditure for an amount of Rs. 5,73,69,795/- has been made. State-wise details are **annexed.**
- (d): The engagement of employees on contractual basis for the ASHA project in Gujarat was for a period upto August, 2018. On renewal of the project in January 2023, process is being initiated to appoint fresh staff.
- (e): The details of funds used for ASHA project during 2017 to 2022 are as under:-

- (f): A total of Rs. 5,73,69,795/- was used by NIOS for the project and Rs.1,91,02,254/- is with the NIOS as an unspent balance.
- (g): The salary paid to ASHA staff is Rs.3,53,77,760/-.
