Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the salient features and the current status of the implementation of the Start-up Village Entrepreneurship Programme (SVEP) ;
- (b) the details regarding the number of blocks that have been identified by the Government for the implementation of the said programme, State/UTwise;
- (c) the number of village enterprises that have been set up since the inception of the said programme;
- (d) the total number of jobs created thereunder since inception and the number of States covered under the said programme, State/year-wise; and
- (e) whether the Government proposes to involve all other States in this regard and if so, the details thereof along with the quantum of funds allocated/ utilised since the inception of the said programme, year-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT

(a) Start-up Village Entrepreneurship Programme (SVEP), the sub-scheme under Deendayal Antyodaya Yojana - National Rural Livelihoods Mission (DAY-NRLM) has the objective of helping members of Self Help Group (SHG) or their family members to set-up small enterprises in the non-farm sector. The salient features of the programme are:

- i. SVEP aims to support rural entrepreneurs by developing an eco-system for supporting small businesses in rural areas.
- ii. The eco-system comprises of a cadre of Community Resource Person - Enterprise Promotion (CRP-EP) who will provide business support services to entrepreneurs.
- iii. A dedicated fund called Community Enterprise Fund (CEF) is set-up to provide seed capital for enterprises.

- iv. A Block Resource Centre (BRC), the dedicated centre at the block level for supporting enterprise promotion is established in each block.
- v. An exclusive team comprising of block anchors, mentors and Block Programme Managers (BPM) - SVEP at the block level with a clear understanding of business dynamics and entrepreneurship helps in implementing SVEP.
- vi. SVEP is a demand driven program. The operational unit program is block. The maximum budget for one block under SVEP is Rs 650.00 Lakh and 2400 enterprises can be supported in one block within the approved funds.

(b) SVEP is currently being implemented in 258 blocks across 29 States/UTs as on 28th February, 2023. The number of SVEP blocks State/UT-wise is provided in **Annexure-I**.

(c) As on 28th February, 2023, a total of 2,31,798 enterprises have been supported under SVEP across 29 States/UTs since inception.

(d) It is estimated that as on 28th February, 2023, the 2,31,798 SVEP enterprises have generated employment for approximately 4,79,822 persons since inception. The State/Year wise details are provided in the **Annexure - II**.

(e) SVEP is a demand driven scheme and there is no State-wise allocation. States submit the proposals and accordingly approvals are given by Empowered Committee of the Ministry. The SVEP has already covered 258 blocks in all 28 States and 1 UT. Further, remaining UTs are being oriented on regular basis about the SVEP. The funds released to the States/UT year-wise is placed as **Annexure – III**.
