**PERSON DAYS UNDER MGNREGS**

4411. SHRI A. GANESHAMURTHI:  
SHRI A. RAJA:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the number of employment days/person days under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) during each of the last three years, State-wise;
- (b) whether there has been demand for more days from the beneficiaries;
- (c) the amount budgeted and spent during each of the last three financial years, State-wise;
- (d) whether there is less allocation of funds in the financial year 2023-24 and if so, whether it will not affect the MGNREGS;
- (e) whether there is any complaint of delay in payment of wages to the beneficiaries; and
- (f) if so, the action taken to resolve the issue and expedite payment?

**ANSWER**

(a) State/UT-wise details of employment provided (in person-days generated) under Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) in the last three financial years 2019-20, 2020-21 and 2021-22 is given at **Annexure-I**.

(b) Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand driven wage employment Scheme which provides for the enhancement of livelihood security of the households in rural areas of the country by providing at least one hundred days of guaranteed wage employment in every financial year to every household whose adult members volunteer to do unskilled manual work.

(c) There is no State/UT-wise allocation of funds under Mahatma Gandhi NREGS. State/UT wise release of funds under Mahatma Gandhi NREGS during last three financial years 2019-20, 2020-21 and 2021-22 is given at **Annexure-II**.

State/UT-wise details of expenditure incurred (including State share) under Mahatma Gandhi NREGS in the last three financial years 2019-20, 2020-21 and 2021-22 are given at **Annexure-III**.

(d) There is a budget allocation of Rs. 60,000 crores at Budget Estimate stage for Mahatma Gandhi NREGS for financial year 2023-24.

Mahatma Gandhi NREGS is a demand-driven wage employment scheme. Funds release to States/UTs is a continuous process and Central Government is committed to making funds available to States/UTs for the implementation of the Scheme as per the demand for work on the ground.

The Ministry seeks additional funds under Mahatma Gandhi NREGS from the Ministry of Finance as and when required for meeting the demand for work on the ground.

(e) & (f) The Ministry receives complaints under Mahatma Gandhi NREGS through Centralized Public Grievance Redress and Monitoring System (CPGRAMS). Since the responsibility of implementation of Mahatma Gandhi National Rural Employment Guarantee Act is vested with the State/UT Governments, all complaints received in the Ministry through CPGRAMS are forwarded to the concerned State/UT Governments for taking appropriate action including investigation, as per law.

The Ministry has taken various steps to ensure timely payment of wages to workers under the Mahatma Gandhi NREGS. These include:

- i. Upscaling of National Electronic Fund Management System (Ne-FMS) in 27 States and 3 Union Territories.
- ii. Intensive consultation with State Governments and other stakeholders to strategize timely payment of wages, verification of pending compensation claims etc.
- iii. Formulation of Standard Operating Procedure for monitoring of timely payment and payment of compensation.
- iv. Review meetings through video conferences with States/ UTs reviewing the status of timely payment and payment of delay compensation.
- v. States/UT's have been requested to ensure timely regeneration of rejected transaction and every fund release is tagged with priority release of rejected transaction.
- vi. States have been requested to ensure correction of invalid accounts as per information provided by PFMS.
