ERROR IN BANK ACCOUNT AND AADHAAR DATA

4418. SHRI M.V.V. SATYANARAYANA: SHRI SRIDHAR KOTAGIRI:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether it is true that farmers are not able to avail of the Rs. 6000 per annum benefit under the PM Kisan Yojana in Andhra Pradesh due to errors in bank accounts and Aadhaar data;
- (b) if so, the steps taken to avoid beneficiary inclusion-exclusion errors in PM Kisan Yojana;
- (c) the time by which the remedial measures to ensure benefits of the scheme are implemented;
- (d) whether the Government has implemented any schemes for providing financial and infrastructural support to women farmers, if so, the details thereof and if not, the reasons therefor;
- (e) whether the Government has any data on number of women beneficiaries under PM-KISAN scheme and if so, the details thereof, State-wise; and
- (f) the steps taken to impart training and awareness about various central schemes in agricultural sector?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE

कृषि एवं किसान कल्याण मंत्री (SHRI NARENDRA SINGH TOMAR)

(a) to (c) PM Kisan Samman Nidhi (PM-KISAN) was launched by Government in February 2019 to supplement financial needs of land holding farmers of the country. Under the scheme, financial benefit of Rs 6000/- per year, in three equal instalments, is transferred into the bank accounts of farmers. It is one of the largest DBT Scheme of the world.

States/UTs identify and verify the beneficiaries under the scheme. Benefits are transferred to the beneficiaries through Direct Benefit Transfer mode, based on verified data received from the States/UTs on the PM-KISAN portal. To help the States/UTs for automated validation of the beneficiaries' data, PM-KISAN portal has been integrated with the portals of Unique Identification Authority of India (UIDAI) for Aadhaar authentication; with Public Finance Management System (PFMS) for validation of account and Government employees/pensioners data; with Income Tax department for validation of income tax payee status; and with National Payment Corporation of India (NPCI) for Aadhaar based payments.

Eligible farmers are enroled and deceased/ineligible beneficiaries are removed by way of continuous verification and validation of the beneficiary's data. The States/UTs have been provided with the option to mark beneficiaries as ineligible to eligible and vice versa, after due verification. E-KYC of all the beneficiaries is also done to verify their status. If payment of a farmer is held by the States due to any concern related to their eligibility criteria and later on when farmer addresses the concern, the farmer becomes eligible for receiving their due payments.

- (d) The Schemes of DA&FW provide financial & infrastructural support for development of Agriculture to the farmers of country which includes women farmers also.
- (e) Period wise number of Female Beneficiaries under PM-KISAN is attached at Annexure –I
- (f) The Schemes of DA&FW are designed to include capacity building of farmers as well as field staffs to disseminate the latest technology for increasing the production and productivity of various crops.
