Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the salient features and objectives of Pradhan Mantri Kisan Tractor Yojana;
- (b) the details of the farmers benefited by the said Yojana in the country including Chhattisgarh during each of the last three years and the current year, State-wise;
- (c) the details of the subsidy provided to the farmers in the country for purchasing tractors under the said Yojana, State-wise; and
- (d) the details of the subsidy provided to the farmers in Chhattisgarh including Bilaspur, Mungeli and Gaurela-Pendra Marwahi districts under the said Yojana, district-wise?

ANSWER

(a) to (d): There is no such scheme in operation under the name 'Pradhan Mantri Kisan Tractor Yojana'. However, financial assistance for purchase of agricultural machinery including tractors is provided under Centrally Sponsored Scheme "Sub-Mission on Agricultural Mechanization" (SMAM) being implemented in all States and Union Territories including the State of Chhattisgarh. Under this scheme financial assistance @ 40% to 50% of the cost depending on the categories of farmers, is provided for purchase of agricultural machines on individual ownership basis. Financial assistance @ 40% of the project cost is also provided to rural youth & farmer as an entrepreneur, Cooperative Societies of Farmers, Registered Farmers Societies, Farmer Producer Organizations (FPOs) and Panchayats for establishment of Custom Hiring Centres (CHCs) and Hi-tech hubs of high value agricultural machines. Financial assistance @ 80% of the project cost for the projects costing up to Rs. 10 Lakhs is provided to the Cooperative Societies, Registered Farmer Societies, FPOs and Panchayats for setting up of village level Farm Machinery Banks

(FMBs). The rate of financial assistance for the North Eastern States for establishment of FMBs is @95% of the project cost for the projects costing up to Rs. 10 lakhs. The district-wise targets for various interventions are firmed up by the States. The Statement of funds released under the scheme, machines distributed to farmers under subsidy and the CHCs/Hi-tech Hubs and FMBs established during each of the last three years and the current year, State-wise including the State of Chhattisgarh is given in Annexure-I
