SOIL TESTING OF AGRICULTURE LAND

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the details of the policies formulated by the Government for soil-testing of the agricultural lands of the farmers;
- (b) whether the Government is conducting soil test through charitable/Non-Government or Governmental organisations and if so, the details thereof;
- (c) if not, the details of the policies regarding launching new Soil Testing Centres;
- (d) the number of fully functional soil testing labs across the country, State-wise;
- (e) the number of permanent and non-permanent employees working in these labs and vacancies for the same, State-wise;
- (f) the details of budgetary expenditure on soil testing labs run by the Government for the last five years;
- (g) whether all labs are adequately equipped in accordance with generally accepted international standards, if so, the details thereof and if not, the reasons therefor; and
- (h) the steps taken to increase the number of such labs at the village level?

#### **ANSWER**

MINISTER OF AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री (SHRI NARENDRA SINGH TOMAR)

(a) to (h): Government has launched the Soil Health Card scheme under National Project on Soil Health and Fertility in the year 2015 with an aim to assist the States/Union Territories to provide Soil Health Cards for all farm holdings across the country. Soil health card provides information to the farmers on fertility status of their soils to enables them to apply soil health card based recommended balanced doses of fertilizers in an integrated way in conjunctive use of chemical fertilizers, organic fertilizers and bio-fertilizers so as expected to reduce the consumption of chemical fertilizers and increase use of organic sources of plant nutrients which in turn improve the soil fertility as well as nutrient use efficiency. Interventions proposed for the Scheme includes development of modalities for soil sample collection along with standard sampling norms, quality control in the soil analysis, training of sampling staff and soil testinglab personnel, intensive use of ICT for database management for faster delivery of soil health cards in PPP mode like charitable/Non-Government and popularizing soil test based Integrated Nutrient Management through field demonstrations.

Under the Soil Health Management scheme there is provision to set up static Soil Testing Labs (STLs), Mobile Soil Testing Labs, Mini Soil Testing Labs and Village Soil Testing Labs besides strengthening of existing laboratories to enable them to undertake micro-nutrient testing. The financial assistance is provided to the states for purchasing of machinery & equipment, chemicals & glassware in Soil Testing Laboratories. No financial assistance is provided to state for hiring of man power. Therefore, the data of employees working in Soil Testing Laboratories in states are not maintained by Government of India. The state-wise details of functional soil testing laboratories sanctioned to states during 2014-15 to 2022-23 are at **Annexure-I.** Details of State-wise release of funds by the Government of India under the scheme during the last five years are at **Annexure-II.** 

Establishment of Village Level Soil Testing Labs has been taken up under Soil Health Management (SHM) scheme with the objective of employment generation for rural youth and improve timelines in analysis of soil samples. Financial assistance for setting up of Village Level Soil Testing Labs can be availed byAgri-Clinics and Agri Business Centres (AC&ABC), Agri-prenures, Ex-servicemen, Self Help Groups (SHGs), Farmer Producer Organizations (FPOs), Farmer Producer Companies (FPCs), Farmer Joint Liability Groups, Farmer Cooperative Societies, PACS, Input Retail Outlets, Input Retailers and Schools / Colleges.Soil Testing Labs are equipped with Indian Council of Agricultural Research (ICAR) validated instruments& equipments who met adequate standards. Government is promoting mini soil testing labs and providing financial assistance to set up in order to increase the village level soil testing labs.
