4538. SHRI ARUN KUMAR SAGAR:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether the work is being conducted under the Digital India Land Records Modernization Programme (DILRMP) in the country especially in the Shahjahanpur Parliamentary Constituency of Uttar Pradesh;
- (b) if so, the details thereof especially for the Shahjahanpur Parliamentary Constituency of Uttar Pradesh as on date along with its updated status; and
- (c) the details of the Central funds allocated and utilized for this purpose as on date during each of the last three years, State-wise?

(a) & (b) Yes Sir, The National Land Record Modernization Programme (NLRMP) was approved by the Cabinet on 21.08.2008 as a Centrally Sponsored Scheme and later revamped under the Digital India initiative and renamed as Digital India Land Records Modernization Programme (DILRMP) and is being implemented as a Central Sector Scheme with effect from 1st April, 2016 with 100% funding by the Central Government.

Substantial progress has been achieved in various components of the Programme at national level {as per Management Information System (MIS) of DILRMP} as given below (as on 22.03.2023).
