### 4547. SHRI SANJAY KAKA PATIL:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

(a) the details of number of approved Mega Food Park projects, State-wise;

(b) the details of the Mega Food Parks that are presently operational, State-wise;

(c) whether it is a fact that for FY 2021-22, for Mega Food Park projects the revised estimates were Rs. 54.37 crore, but as of 21.01.22 the actual expenditure was around Rs. 31.34 crore only; and

(d) if so, the details thereof along with the reasons for only 57.64% utilisation of the allocated funds?

#### ANSWER

# THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

(a) & (b): The Ministry of Food Processing Industries (MoFPI) has been implementing the Mega Food Park (MFP) scheme, a sub-scheme of Pradhan Mantra Kisan Sampada Yojana (PMSKY), for creating modern infrastructure for the food processing sector along the value chain from farm to market.

Since inception of the MFP Scheme, MoFPI has approved 41 MFP projects, out of which 23 are operational. The list of MFP project with status of implementation, is given at **Annexure**.

(c) & (d): In the financial year 2021-22, Rs.52.59 crore was spent under the MFP scheme (96.726% of RE of Rs.54.37 crore). The release of grants-in-aid depends on the claims submitted by the respective projects on completion of milestones stipulated in the guidelines of the scheme.
