Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the number of farmers registered under Pradhan Mantri Fasal Bima Yojana (PMFBY) in various States of the country, State-wise particularly in Maharashtra, Dadra and Nagar Haveli and Daman and Diu;
- (b) the number of farmers particularly in the said areas availing benefits under the scheme for both Kharif and Rabi seasons, district-wise; and
- (c) the number of insured farmers provided compensation against the damage of their crops due to torrential unseasonal rains and other reasons during Rabi season, State-wise?

ANSWER

(a) to (c) : The Pradhan Mantri Fasal Bima Yojana (PMFBY) provides for comprehensive risk insurance against crop damage due to non-preventable natural risks from pre-sowing to post-harvest for the crops/areas notified by the concerned State Government. The scheme is voluntary for the States as well as farmers. Union Territory of Dadra & Nagar Haveli and Daman & Diu is not implementing the scheme. District-wise details of number of farmers enrolled during Kharif 2021 and Rabi 2021-22 season in Maharashtra are given in **Annexure-I**. State-wise details of number of farmer applications enrolled and claims paid under the scheme during 2021-22 are given in **Annexure-II**.

The major part of the scheme except localized calamities and post harvest losses, is implemented on Area Approach basis and season-end claims are worked out on the basis of yield data submitted by the concerned State Government after the harvesting period and reasons for loss/claims are not ascertained under the scheme.
