Will the Minister of PLANNING be pleased to state:

- (a) the details of each of the Sustainable Development Goals (SDGs);
- (b) the status of timelines of each of the SDGs along with the progress made in achieving each of them by India;
- (c) whether the Government has carried out any study about the progress made in achieving the 17 goals and 169 targets of the SDGs signed in 2015 by 2030, if so, the details and findings thereof;
- (d) the manner in which the Government looks at the recent report of The Lancet that India is not on the target to achieve 19 of the 33 Sustainable Development Goals; and
- (e) the details of the corrective measures taken/ proposed to be taken by the Government to achieve targets of SDGs within the timeframe?

- (a): The Sustainable Development Goals (SDGs) are a set of 17 goals and 169 targets to help organize and streamline development actions for greater achievement of human wellbeing, while leaving no one behind – by 2030. They are part of Transforming our world: the 2030 Agenda for Sustainable Development, which was adopted by 193 Member States at the historic United Nations General Assembly Summit in September 2015, and came into effect on January 1, 2016. A statement indicating SDG goals is annexed (**Annexure-I**).

(b) &(c) : The SDGs are designed to be achieved by 2030. SDG India Index was conceived in 2018 by NITI Aayog following the need for a monitoring framework to track the progress of SDG implementation in the country. It is the most comprehensive single performance measurement policy tool to gauge the performance of India and its States/UTs. It represents evidence-based policymaking by supporting States and UTs to benchmark their progress, identify the priority areas and take corrective measures to achieve SDG targets. A statement indicating State-wise achievement as per SDG India Index Report 2020-21 is annexed (**Annexure-II**).

(d) & (e): Many international agencies are publishing global indices based on different databases and methodologies. Many times they use open source data, which may or may not be reliable and often do not reflect the true status of development. The Government of India has been focusing on inclusive growth and is implementing several schemes in the country. These include Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS), Pradhan Mantri Awaas Yojana – Gramin (PMAY-G), Pradhan Mantri Gram Sadak Yojana (PMGSY), Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM), Deen Dayal Upadhyay – Gramin Kaushalya Yojana (DDU-GKY), Rural Self Employment Training Institutes (RSETIs), National Social Assistance Programme (NSAP), PM Street Vendor’s AtmaNirbhar Nidhi (PM SVANidhi) Scheme, Shyama Prasad Mukherji Rurban Mission (SPMRM), Pradhan Mantri Garib Kalyan Anna Yojna (PMGKAY), Aspirational Districts Programme, Pradhan Mantri Kisan Samman Nidhi, Pradhan Mantri Kisan Maan-Dhan Yojana, Skill India, Sansad Adarsh Gram Yojana, Pradhan Mantri Jan-Dhan Yojana (PMJDY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), Pradhan Mantri Jeevan Jyoti Bima Yojana, Atal Pension Yojana, Pradhan Mantri Mudra Yojana, Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB PM-JAY), Stand Up India Scheme, Pradhan Krishi Sinchai Yojana, Swachh Bharat Mission (Rural and Urban), etc.
