- (a) whether the Government has received any proposal from the State Governments for grant of GI tag for its products and if so, the details thereof;
- (b) the steps taken and the schemes evolved to encourage the stakeholders of GI tags in India; and
- (c) the schemes that have been evolved and the steps taken by the Government to identify and encourage potential GI tag worthy items in the country?

#### **ANSWER**

### वाणिज्य एवं उद्योग मंत्रालय में राज्य मंत्री (श्री सोम प्रकाश) THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE & INDUSTRY (SHRI SOM PARKASH)

- (a): No Sir, no such proposals are received from the State Govts for Registration of Geographical Indications (GI) under Geographical Indications of Goods (Registration & Protection) Act, 1999.
- (b) & (c): The Government has taken several initiatives to encourage GI stakeholders and potential GI tag worthy items, prominent among which are:
  - i. "Initiative for Promotion of Geographical Indication (IPGI)" under IPR Policy Management scheme has been taken up by DPIIT for which, an amount of Rs. 75 Crores has been earmarked for three years i.e. 2022-23, 2023-24 and 2024-25 towards promotional activities of GI products.
  - ii. Ministry of Micro Small and Medium Enterprises (MSME) grants Financial Assistance of Rs. 2.00 Lakh on grant of registration under Geographical Indications of goods
  - iii. Several events have been organised to showcase the potential of GI tagged products, wherein dedicated 'GIPavilions' have been set up. The details of the events are attached as Annexure -I
