Will the **MINISTER OF HEALTH AND FAMILY WELFARE** be pleased to State:

- (a) the fund allocated to the Low Performing and High Performing States under the Janani Suraksha Yojana, State-wise;
- (b) the fund allocated to Bhagalpur Parliamentary Constituency under the said scheme during the last four years and the current year;
- (c) whether utilization rate of fund in Low Performing States continues to be low and if so, the reasons therefor;
- (d) whether the Government proposes to increase the incentive given to promote institutional delivery and if so, the details thereof;
- (e) whether the Government maintains data of ASHA workers appointed by the Ministry, district-wise and if so, the details thereof; and
- (f) the number of patients benefitted under the Ayushman Bharat Yojana in Bhagalpur Parliamentary Constituency during the last three years and the current year and the amount paid to the Government and private hospitals for treatment during the said period, year-wise?

- (a) Under National Health Mission (NHM), the funds allocation for the Janani Suraksha Yojana (JSY) is done as part of RCH Flexible Pool. Details of approvals under JSY to Low Performing States (LPS) and High Performance States (HPS) respectively in FY 2021-22 is attached at **ANNEXURE-I**.
- (b) The fund allocated to Bhagalpur Parliamentary Constituency under Janani Suraksha Yojana (JSY) during the last four years and current year as shared by the State of Bihar is given below:

(d) As of now, there is no such proposal to increase incentive given to promote institutional delivery under JSY.

(e) Ministry of Health and Family Welfare, Government of India provides financial and technical support to the States/UTs for strengthening their healthcare systems based on the Programme Implementation Plans (PIPs) submitted by States/UTs within their overall resource envelop.

As per NHM-MIS (as on 30.09.2022), State –Wise details of total number of ASHAs engaged by States/UTs under National Health Mission(NHM) all over country, except Goa and Chandigarh, are given at **ANNEXURE-II**.

(f) Ayushman Bharat Pradhan Mantri - Jan Arogya Yojana (AB PM-JAY) is the largest publicly funded health assurance scheme in the world which aims to provide health cover of Rs. 5 lakhs per family per year for secondary and tertiary care hospitalization to 12 Crore families.
