Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether the Government proposes to set up or proposed to set up more Eklavya Model Residential Schools (EMRS) in the country, State-wise including Hazaribagh and Ramgarh districts of Jharkhand, Dadra and Nagar Haveli, Daman and Diu, district-wise, Mumbai of Maharashtra, Rajasthan and Madhya Pradesh during the last five years to bridge the gap in education of tribal children in remote areas, location-wise;
- (b) the locations out of the above mentioned locations where EMRS have not been started yet along with the target to start construction and teaching at said EMRS and the steps taken to operationalise those which are not functional so far, State-wise;
- (c) the total amount planned to be spent per student per year in these schools, State-wise;
- (d) the total number of sanctioned and functional EMRS in the country, State-wise including in Hazaribagh and Ramgarh of Jharkhand along with the funds sanctioned during the current year;
- (e) whether the Government is aware of the digital gap in the country especially among the tribal children who were unable to attend online classes due to lack of critical technical infrastructure for online classes during the pandemic, if so, the steps being taken by the Government to enhance the technology capability of EMRS schools; and
- (f) whether mobile facility is also likely to be provided in such schools in future to solve the problem of connectivity and if so, the details thereof?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SMT. RENUKA SINGH SARUTA):

(a) to (d): Government has decided to establish Eklavya Model Residential Schools (EMRS) in every block with 50% or more ST population and atleast 20,000 tribal persons. A total number of 740 EMRSs are scheduled to be established across the country by the year 2025-26, out of which 690 schools have already been sanctioned and 401 EMRSs are reported to be functional. Since no block fulfils the criteria for establishment of EMRS as per the schematic guidelines, no EMRSs have been sanctioned in Hazaribagh and Ramgarh district of Jharkhand, and Mumbai district of Maharashtra.

The State-wise details of sanctioned and functional EMRSs including that of Dadra & Nagar Haveli, Daman and Diu, Rajasthan and Madhya Pradesh during the last five years are at **Annexure-I**. District-wise and location-wise list of EMRSs sanctioned in Dadra & Nagar Haveli, Daman and Diu, Rajasthan and Madhya Pradesh during the last five years with their functional and construction status is at **Annexure-II**. Ministry in coordination with National Education Society for Tribal Students (NESTS), an autonomous organization to manage and implement the scheme of EMRS, is continuously coordinating and following up with the State Governments to get suitable land free from all encumbrances, including forest clearance. States have been advised to run schools in alternative buildings preferably in Government Buildings till the construction of schools is completed.

The approved capital cost for construction of EMRS is Rs.37.80 crores for plain areas which can go upto Rs. 48.00 crores in case of Northeast, Hilly and LWE affected areas. Recurring cost of Rs.1,09,000.00 per student per year is given to schools towards running and managing the school. Fund is released to NESTS and NESTS further releases funds to States/ UTs/ PSUs/ Construction Agencies/ State Societies as per their requirements for construction of EMRSs and recurring cost for running of the schools. During the current financial year, i.e. 2022-23, Ministry has released an amount of Rs.1,465.27 crore to NESTS for implementation of the scheme of EMRS (as on 31.01.2023).

(e) and (f): Government is sensitive about the digital gap in the country especially among the tribal children. In order to ensure digital connectivity, Ministry has planned to set up technology enabled classrooms in coordination with Ministry of Electronics and Information Technology (MeitY) through ERNET in 175 EMRSs, with dedicated lease line through BSNL in phase-I.
