Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the present status of implementation of the National Oral Health Programme (NOHP) in the country, State/UT-wise;
- (b) the clinics/hospitals covered, the activities undertaken, the facilities provided along with the number of beneficiaries under the programme during each of the last three years and the current year, State/UT-wise;
- (c) the funds allocated and spent on various heads under this programme during each of the last three years and the current year, State/UT-wise;
- (d) whether the Government proposes to formulate a time bound action plan for extending the reach of the said programme to all the medical colleges and district hospitals in the country and if so, the details thereof; and
- (e) the steps taken/being taken by the Government to combine preventive measure with emphasis on education to create oral health awareness among the various segments on the population.

**ANSWER

- (a) to (e) National Oral Health Programme was launched in India in 2014. The Programme is functional across 36 States/UTs. Under the programme, financial support for equipment, consumables, training, IEC activities and recruitment of manpower has been provided to States/UTs to establish dental care unit at the level of District hospital (DH), Sub District Hospital (SDH), Community Health Centre (CHC), Primary Health Centre (PHC).

6023 dental care units have been established at 593 districts which includes 593 DH, 1056 Sub-District Hospital (SDH), 3229 Community Health Centre (CHC) and 1124 Primary Health Centre (PHC) as well as 21 Mobile Dental Units. The State/UT wise implementation status of the Programme is attached as **Annexure A**.

The facilities provided by the dental care units established through the Programme are :Screening for Oral diseases, root canal treatment, extraction, oral prophylaxis, restorations. The number of beneficiaries State/UT wise under the Programme is attached at **Annexure B**

The details of the funds allocated and spent at Central level is as under:-

- i) National Centre of Excellence for implementation of NOHP at Centre for Dental Education and Research (CDER), AIIMS.
- ii) National Resource Centre for Oral Potentially pre-malignant Disorders at Lady Hardinge Medical College (LHMC) and Associated Hospitals, New Delhi.
- iii) National Resource Centre for Tobacco Cessation and Oral Health at Maulana Azad Institute for Dental Sciences (MAIDS), New Delhi
- iv) Oral health of children and elderly at Postgraduate Institute of Medical Education and Research (PGIMER), Chandigarh
- v) Collaborative oral health promotion and prevention activities with NOHP dental care units at States/UTs, Dental Colleges (through Dental Council of India), Indian Dental Association
