IMPLEMENTATION OF PROJECTS UNDER SAGARMALA PROGRAMME

- (a) the details of projects sanctioned/completed under the Sagarmala Programme in the country including expenditure incurred and contribution of the States in these projects, State-wise including Odisha;
- (b) whether 800 projects at an estimated cost of Rs. 5.4 lakh crore have been identified for implementation under Sagarmala Programme which is based on port-led initiatives in the country and if so, the details thereof, State-wise;
- (c) whether the Government has identified ports in the country to make port-led developments and if so, the details thereof, State-wise including Maharashtra and Odisha;
- (d) whether the Government is planning any new project under Sagarmala Programme and if so, the details thereof, State-wise including Odisha; and
- (e) whether Government has identified any special economic zones to develop under Sagarmala Project and if so, the details thereof, State-wise including Odisha?

ANSWER

MINISTER OF PORTS, SHIPPING AND WATERWAYS (SHRI SARBANANDA SONOWAL)

(a) & (b) As a part of Sagarmala Programme, more than 800 projects at an estimated cost of around Rs. 5.4 lakh crore have been identified for implementation during 2015 to 2035 across all coastal states on Eastern and Western side of the country. Out of the total projects, 221 projects worth Rs. 1.12 lakh crore have been completed and 581 projects worth Rs. 4.27 lakh crore are under various stages of implementation and development. The state-wise summary of Sagarmala Programme Projects including Odisha is provided at Annexure-I.

Under Sagarmala Scheme, Ministry of Ports, Shipping and Waterways has partially funded 170 projects worth Rs. 10,900 Cr across coastal states and UTs. Out of 170 projects, 47 projects worth Rs. 2,900 Cr. have been completed and 123 projects worth Rs. 8,000 Cr. are under various stages of implementation and development. The state-wise summary of Sagarmala Funded Projects including Odisha is provided at Annexure-II.

- (c) & (d) Yes Sir, Sagarmala Programme is divided into five pillar namely Port Modernization, Port Connectivity, Port Led Industrialisation, Coastal Community Development and Coastal Shipping & IWT which includes projects from various categories such as modernisation of existing ports and terminals, new ports/ terminals, RoRo/ RoPax& tourism jetties, enhancement of port connectivity, inland waterways, lighthouse tourism, industrialization around ports, skill development, technology centres etc. These projects are being implemented by the Central Line Ministries/ Departments, State Governments/ Departments and Major ports etc. The pillar-wise details of Sagarmala Programme is provided in Annexure III.
- (e) National Industrial Corridor Development and Implementation Trust (NICDIT) under the administrative control of Department of Promotion of Industry and Internal Trade (DPIIT) in partnership with respective state Govt(s) / Central Agencies is developing various Industrial Corridor Projects as a part of National Industrial Corridor Programme. Initially, Ministry of Ports, Shipping and Waterways under National Prospective Plan of Sagarmala Programme identified 14 Coastal Economic Zones. Ministry has now requested NICDIT to associate with Major Ports and develop available land at with Major Ports as a part of Industrial corridors / nodes in the industrial corridor programme.
