- (a) whether the Government is implementing the schemes for creating health awareness in the country;
- (b) if so, the details thereof;
- (c) the details of target achieved in this regard; and
- (d) the funds utilised on such schemes, State/UT-wise?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

- (a) to (c) Swastha Nagrik Abhiyan (SNA), is a Central Sector Scheme implemented by Government of India and aims to support the key goals of the National Health Policy and the Sustainable Development Goals (SDGs) focusing on ensuring healthy lives and promoting the well-being of all at all ages. Under this scheme, Information Education and Communication (IEC) activities are planned in consultation with the respective Programme Divisions, and as per their programmatic priorities. IEC activities are taken up by the States/UTs as per the priorities of the diseases under National Health Mission (NHM) program.
 - IEC activities have encouraged health seeking behavior among the masses resulting in better health outcomes through various Health programs of Government.
- (d) The details of funds released to States/UTs through Program Implementation Plans (PIPs) under National Health Mission(NHM) during the last three financial years (2019-2022) are given at Annexure-I
