# LOK SABHA UNSTARRED QUESTION NO. 4991 TO BE ANSWERED ON 31.03.2023

#### SMARTPHONE TO ANGANWADI WORKERS

#### 4991. SHRI BHAGIRATH CHOUDHARY:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether the Government has formulated a scheme to provide Make in India smartphones for enabling the Anganwadi workers to maintain digital record rather than the written record since maintaining record of the huge number of persons is a tiring and time consuming task and if so, the details thereof;
- (b) whether any timeline has been fixed to provide smartphones to all the Anganwadi workers in the country including Rajasthan and if so, the total number of States/UTs in which the said smartphones have been distributed so far;
- (c) the total amount of Budget allocated for the said purpose during the period from 2019-20 to 2023-24; and
- (d) the total amount spent for the said purpose so far, year-wise and State/UT-wise?

#### **ANSWER**

## MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) Under POSHAN Abhiyaan, Anganwadi workers (AWWs) have been technologically empowered with the provision of smartphones procured through Government e-Market (GeM) for efficient service delivery. Close to 11 lakh Smartphones have been procured by States/UTs, so far, which includes the state of Rajasthan.

Further, the ICT based mobile application named as Poshan Tracker has helped in digitizing and automating the physical registers used by Anganwadi workers. This saves the time of AWWs and AWHs, and improves the quality of their work while simultaneously facilitating monitoring of data and service delivery.

(b) Since the launch of the Abhiyan, the Ministry has been directing the States/UTs to procure smartphones. As on date, all States/UTs have procured smartphones except few States which are in the process of procurement, as informed by these States.

(c) Poshan Abhiyan is a Centrally Sponsored Scheme at a cost-sharing basis, within which funds are allocated to States/UTs for various sub-components, including procurement of smartphones and Growth Monitoring Devices, Jan Andolan activities, innovations, Community Based Events, Data recharge for smartphones etc.

Procurement of Smartphones is one of the sub-components. As per the Scheme Guidelines, the sanctioned amount is Rs 8000/- *plus* taxes for each smartphone.

The year- wise details of the budget allocated to Poshan Abhiyan from FY 2019-20 to FY 2022-23 as on 27.02.2023 are as under:
